- All sculpture submissions must be original.
- Delivery, installation and removal of work is the responsibility of the artist
- Sculptures must remain on display for the duration of the exhibition
- Artist is responsible for own insurance
- All sculptures must be available for sale. GIPPSLAND SCULPTURE EXHIBITION deducts a commission of 33% (inc GST) for all sales made throughout the 2019 Gippsland Sculpture Exhibition.
- There is a \$44 artist fee to assist with administration costs (covers any number of entries)
- A selection panel will determine successful entries and all artists will be notified by email
- Details of site/gallery will be mailed.
- Artists of larger exterior submissions will be contacted to discuss position and installation details
- Prizes will be awarded at Opening event – invitations will be posted
- Judges for the 2019 exhibition will be Colin Suggett & Catherine Larkins
- All signage will be provided
