## **PRIZES**

**Major Prize of \$2,000 awarded for the best exhibit as decided by the judging panel.**

**Minor Prize of \$500 for highly commended works as decided by the judging panel. These will be announced on Saturday 16<sup>th</sup> October.**

**Peoples Choice of \$300 voucher will be awarded from votes cast by gallery visitors over the duration of the exhibition. This prize will be announced on Tuesday 23 November.**

**arc Yinnar** is an artist run initiative in central Gippsland, Victoria. In operation since 1982 **arc** is governed by a collective of management comprised of its membership who include local artists, educators and craftspeople. **arc** is a vital facility dedicated to supporting and promoting contemporary arts activities for artists in the Latrobe Valley and the wider Australian community.

## **GUIDELINES**

**The Biennial arc Yinnar Drawing Prize** is open to drawings of a traditional, contemporary or innovative nature. Drawings are to be a unique work on paper or other suitable support and will be judged on their graphic qualities. Materials may include those used traditionally such as pencil, ink, charcoal, and contemporary media as an element of the

work such as collage and watercolour will also be accepted.

**Judging** – independent judges for the awarding of prizes are **Catherine Larkins** from East Gippsland and **Colin Suggett** of Venus Bay. The decisions made by the judging panel are final and no correspondence will be entered into.

### **Entries**

Artists may enter up to two drawings for pre-selection. All entries must have been completed since January 1<sup>st</sup>, 2009 and must be the original work of the artist. Works may be framed or unframed. **Maximum size** limit of 2 square metres (e.g. 2 x 1m, 1.3 x 1.5m, or other configuration). Exception to this only would be installation works that include floor space.

### **Pre-selection and Fees**

Entry Form, fees and images for pre selection to be received at **arc Yinnar** by 4 PM, Friday 13<sup>th</sup> August (if hand delivered). Entries received by post should be postmarked August 13<sup>th</sup> or earlier.

High quality images of each work must be either: clearly labelled slides; or digital images on a clearly labelled disk. Digital images must be jpg or tif format, 300 dpi, 2Mb maximum per image. Images will be returned by post. Late entries will not be accepted. A non-refundable entry fee of \$27.50 (includes GST) per entry must accompany the Entry Form. Money orders and cheques should be made payable to "arc Yinnar". Payment by Mastercard or Visa can be made by completing that section of the Entry Form.

## **Notification**

Artists will be notified of pre-selection outcome by Friday 27<sup>th</sup> August, and images will be returned by post.

## **Delivery of Works**

For those artists selected, all works need to be delivered either:

**In person** to arc Yinnar, Main St, Yinnar;

**By post** for unframed entries to PO Box 216 Yinnar 3869.

NB. If posting please use flat parcel rather than tubing. Australia Post parcel size limits up to 20 kg are: L 105 cm, W 105 cm, girth 140 cm;

**By courier** to arc Yinnar, 19-23 Main St, Yinnar (opp. General store).

**Please included self addressed stamped packaging for the return of your work, or ph: 51631310 to make alternative arrangements.**

## **Delivery Dates:**

**October 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup> (Fri, Sat, Sun) 12-3 PM. Postal deliveries will be accepted from October 2<sup>nd</sup> – 6<sup>th</sup>.** All works should be clearly labelled on the back with: artists name, address, title of work and selling price including commission of 27.5%.

## **Hanging Instructions**

All framed works need to be ready to hang with picture wire. Unframed works - please advise on preferred hanging instructions ie: clips, pins or provide tabs to be pinned. Installation pieces need to be delivered with complete installation instructions including a photograph or diagram.

## **Insurance**

**arc** Yinnar is not insured against damage or loss of art works during transit or on the premises. All care but no responsibility will be taken.

## **Transport of works**

The artist is responsible for transport costs to and from the exhibition. If you require **arc** Yinnar to return works by post/courier please indicate this and include or arrange payment as appropriate.

## **Sales**

All work must be for sale and will attract a commission of 27.5% (includes GST). Price of works must be the retail price.

## **Promotion**

**arc** Yinnar reserves the right to reproduce exhibited works for publicity, cataloguing and archival purposes. The signed Entry Form is evidence of consent.

## **Exclusion**

Members of the exhibition sub committee are ineligible to exhibit.
